- I am aware that sports clubs of My Fitness Ltd. (hereinafter — the Club) has equipment and facilities that may, *inter alia*, endanger the health and life of the Child, and I hereby assume full responsibility of the action, health condition, life and safety of the Child in this regard;
- I have been informed and I am aware that, during the visit to the Club, the Child may be exposed to increased physical load, which may endanger the health of the Child, and I hereby assume full responsibility of the health condition and life of the Child in this regard;
- the health condition of the Child allows the Child to perform physical exercises of all kinds and amounts, incl. those of increased physical load;
- I hereby agree that, until reaching the age of 16, the Child will visit the Club and use the services, equipment and facilities available therein, incl. the swimming pool, accompanied by another person of full age, and I undertake the duty of ensuring a companion of full age for the Child during all visits;
- I assume full responsibility for the Child, his/her health condition, safety, life protection, action, acts and omissions, and each and every decision taken by the Child in cooperation with the Club or in respect to it, including the cases when the Child is visiting the Club accompanied by another person of full age;
- I hereby agree that My Fitness Ltd. as the controller is processing my and Child's personal data (name, surname, personal identity number, telephone number) to ensure the performance of the contract and/or to contact the Child or the legal representative of the Child. I agree that the personal data storage period corresponds to the period of keeping contracts under the regulatory enactments. I hereby acknowledge that all personal data provided to My Fitness Ltd. are correct and assume full responsibility of providing false personal data;
- I agree with taking photos of the Child, otherwise presentation of a personal identification document (passport or ID card) will be required each time when the Child is visiting the Club;
- I have read the General Conditions, Booking Rules, Kids Room Rules of Order, Rules of Internal Order of the Swimming Pool Facility, Rules for the Climbing Wall, Rules for Squash Court, Rules of Use of the Solarium, Rules of Internal Order and Payment of Services, and the Price List of the Services, and I have explained them to the Child. I also undertake to ensure compliance with the aforementioned conditions and that the Child is complying with them.

I also acknowledge that this consent shall come into effect at the moment of signing and it remains effective until the Child comes of age.
